Global-Estate Resorts, Inc. (GERI) Chairman of the Board, Andrew L. Tan, announced today the appointment of new GERI senior executives.

Monica T. Salomon was appointed as the new President of GERI, bringing to GERI more than 15 years of real estate management experience in Megaworld Corporation. As Head of Megaworld's Corporate Management Division, she spearheaded strategic real estate acquisitions and joint ventures for the Megaworld Group.
