#### **REPORT**

- 1. The Philippine Stock Exchange (PSE), in its regular meeting on January 22, 2014, approved the application of Global-Estate Resorts, Inc. (GERI) to list an additional 100,000,000 common shares, with a par value of Php1.00 per share, to cover the Company's Executive Stock Option Plan (the "Plan Shares") at an Exercise Price of Php1.69 per share, which approval was received by GERI by mail on 29 January 2014.
- 2. The actual listing and eligibility for trading of the Plan Shares will take effect after compliance by GERI with the post-approval requirements of the PSE.
