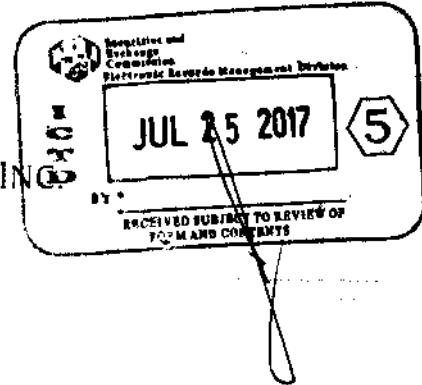

We hope for your favourable consideration of our request.

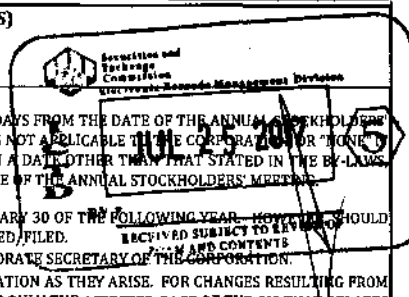
